| What would the estimated balance be after 12 months based on a £1,000 deposit? | Effective from 19th December 2025 until 5th January 2026  The estimated balance would be: £1,012.50.  Interest totaling £12.50 will be credited to your Current Account (based on a 365 day year).  Effective from 6th January 2026  The estimated balance would be: £1,010.00.  Interest totaling £10.00 will be credited to your Current Account (based on a 365 day year).  Assumptions:  • No withdrawals are made; • No further deposits are made; • The interest rate does not change during the 12 month period.  |
| How do I open and manage my account?   | To open a Deposit Account you must have a Current Account with us – please speak to your relationship manager who can help you with this.  To manage your Deposit Account you can give us instructions in person, by telephone or in writing and, at our complete discretion, by email or facsimile. You may be able to instruct us via Online Banking or our App if you have signed up to these services.  No minimum deposit is required to open the account.  No minimum balance is required to maintain the account. There is no maximum amount that can be held in the account. |
